



Guest Conditions of Hire

Tentative bookings are held for a period of two weeks and will be confirmed upon receipt of deposit of \$50.

If deposit is not received within this time the booking will be automatically cancelled.

Bookings are not transferable to another party.

Management reserves the right to allocate facilities at its discretion to accommodate all guests.

Every effort will be made to provide accommodation specifically requested.

Payment

Full payment is required on arrival. No admittance to accommodation will be permitted unless payment is received.

Payment may be made with Cash, Cheque/Postal Order or Credit Card (2% fee)

Catering:

* Bookings are self catered in Cottages, Family Units, House and Bunkhouse

* Health and safety regulations must be adhered to

What to bring:

* Your own towel, fitted sheet, bedding/sleeping bag, pillow and teatowels.

* Cleaning materials - it is a condition of hire that facilities are thoroughly cleaned before departure.

* Sporting equipment - tennis racquets, footballs, soccer balls, cricket gear.

What NOT to bring:

* PETS - no pets of any kind are permitted on site.

* Roller blades, scooters, skate boards; or similar are not permitted on site.

* CARAVANS/TENTS - of any type or size are not permitted on site.

* ALCOHOL is not permitted on site.

On Arrival: Please report to Office/Management for payment, briefing and access to keys.

ALL guests and their visitors are required to report to office on arrival.

Check In time: Incoming guests are able to arrive after 2pm.

Parking:

One car permitted per booking. All other vehicles must be parked in overflow carpark area.

Visitors cars must not proceed past office and be parked in the visitor carpark.

NO boat washing or flushing of boat engines permitted on site.

Furniture

NO DISMANTLING of furniture permitted.

Beds/couches etc are to be kept in their original position.

Plastic tables/chairs may be used outside of accommodation but must be replaced in their original position before departure.

* Supervision of children is required at all times.

* It is recommended that children under the age of 9 years sleep on a bottom bunk.

* **SMOKING** is not allowed in any building. Please extinguish butts and place in pits provided.

* **NOISE** is to be kept to a minimum between the hours of 10pm and 8am.

* **FIRES** are not permitted on site or on the beach.

* All food scraps to be placed in rubbish bins. No food to be left out for native animals.

* **CLOTHESLINES** are located at each accommodation area. Please use these for all washing.

NO temporary clotheslines are to be erected on balconies etc.

Emergency Procedures:

EMERGENCY ASSEMBLY AREAS are located on each oval. Emergency procedure notices and equipment are placed around the campsite. Familiarise yourself with these and ensure that you have an emergency procedure.

Guests are not to tamper or interfere in any way with any safety equipment i.e. fire alarms, smoke detectors etc.

On Departure:

All guests are required to clean the facilities prior to departure and ensure accommodation is left in a clean and tidy condition.

A minimum fee of \$50 will be charged for any accommodation left unclean/untidy.

Damage to any property & equipment will be invoiced to you.

A minimum fee of \$80 will be charged for any graffiti/damage no matter the size or type of discretion.

Check Out time: Outgoing guests are required to vacate premises by 10am.

Late Checkout: Arrangements for late checkout may be available upon request. A late fee may apply.

* Management reserves the right to ask any person who does not abide by the rules of the camp to leave the property.

* Any conduct inconsistent with the Baptist Churches of WA beliefs and purposes will be deemed unacceptable behaviour.
